II. Important Information Extracted from the MOH Media Statement

With the consent of His Majesty the Sultan and Yang Di- Pertuan of Brunei Darussalam, it is hereby announced that the control measures informed in the press conference on 7 August 2021 is further restricted with immediate effect until 21 August 2021 as follows:

- 1. No Mass gatherings.
- 2. Only essential workers can go out to work. All officers and staff work-from-home.
- 3. No one is allowed to leave their house without any important reason. Only two people from one family are allowed to leave the house to buy daily necessities.
- 4. As the country is now facing an increase of locally transmitted cases COVID-19 vaccination supplemented by physical distancing measures and mask-wearing remains the most effective way

for Brunei Darussalam to emerge safely from this pandemic.

5. Those who received mandatory isolation order or self-isolation order shall not leave home, incl. Going to have shots. Anyone with Red or Yellow Bruhealth Code shall not leave home.

III. Covid Prevention Progress in the Company

- 1. Company publicity
- 1.1 Announcement of Company Covid Prevention Strategies: the latest Covid situation and the Company's regulations are updated every day by means of staff group chats.
 - 2. Logistics supports
- 2.1 In Offices: 2 times of disinfection each day Incl. Refining Zone 3 Field Operator Room and CCR, Surau. Keep records.
- 2.2 Commuting services: Full disinfection before shuttle service. After arrival at office area, disinfect again. Tier-by-tier management is initiated with team leader, shift leader and dept supervisor reporting drivers' health conditions, vehicle disinfection picture shown to management, everyone involved signing the promise documents. Once one person is found to breach the regulations, the entire team will be punished.
- 2.3 Lockdown of living quarters off the PMB: lockdown covers 870 staff living in dormitories under centralized enclosed management. Another 179 staff living in rented houses under self-enclosed management, report to chiefs before 21:00 on health conditions, and chiefs report to HoDs before 22:00. Report in case of any abnormal situations.
- 2.4 In the three closed management communities, the only entrance and exit has been set up. The door opening time is opened according to the work shift time. It is closed at other times. Under special circumstances, report level by level. After receiving the confirmation from the ministers, Wang Zelong (contact number: 8399666) will notify the guard to let it go and make a record.
- 2.5 Followup Regulations on Apartment Management has been released for the strict compliance of all dept.
 - 3. Health monitoring and medical care services
- 3.1 A guard booth at the entrance of the refinery has been installed and put into use, staff members coming to work on the PMB are checked of their body temperatures and wearing of masks every day. No abnormality was found in today's inspection.
- 3.2 After investigation, a total of 41 direct close contacts have been isolated and observed as required. So far, 31 expat workers tested negative. They will have one-week work-from-home. 3 of local workers tested negative so far, other ppl waiting the results.
- 3.3 The emergency clinic on the PMB is operating normally, the Company is continuously checking on its self-enclosed management.
- 3.4 COVID-19 prevention medicine: 99 boxes of Lianhua Qingwen capsules for cold, 99 boxes of Jinhua Qingqing particles for cold, 75 big bags of Ban Langen granules.
 - 4. Communications with the government

Due to cases of infection among employees of the company, the embassy requested that the news

be notified from today.

- 5. Materials Availability Assurance
- 5.1 Materials inventory

Material consumption status: 100 disposable protective clothing, 50 KN95 masks, and 50 medical gloves. 30 protective goggles, 10 galons of disinfection liquids.

Materials currently in stock: 2217 disposable medical surgery gowns; 2,335 KN95 Masks; 82,050 disposable masks, 9250 medical gloves; 5 thermometers; 368 protective goggles. 71 spraying bottles (2L); 114 bottles of disinfectant sprays; 812 bottles of sanitizers; 102 galons of big bottles of disinfectant liquids (1 galon/bbl); 90 bottles of disinfectant liquids (3L).

- 6. Contractor Management During the COVID-19 Pandemic
- 6.1 The Port Sub-department: Contractor Jiangsu Haihong has 123 employees, while CSCPE has 87. There is already a daily health report system in place, monitoring the body temperature and symptoms like cough, diarrhea, fever, cold, etc. People living on the ship are not allowed to leave the ship, while those living in dormitories off PMB are not allowed to go out after work. Office management are also strengthened, staff coming in and going out of the office must register and have their temperatures measured. Meanwhile, two engineers are assigned to a post near the ship, they are responsible for the ship management as well as their self-protection.
- 6.2 The Equipment Management Dept.: Clear instructions have been given on the pandemic prevent and control management of the department's 8 contractors. The contractors' employees are all under an enclosed management. They are required to report their temperatures on a daily basis and wear masks, and they are not allowed to go out unless necessary so as to minimize exposure. The department will also inspect regularly to ensure that the anti-pandemic measures have been thoroughly carried out.
- 6.3 The HSSE Dept. has confirmed that the security company has already arranged for the 51 security guards working on PMB to stay in the River Place dormitories for an enclosed management. Surprise inspections are carried out to River Place dormitory, with good results.
