

II. MOH Measures

Those who do not wear masks during the epidemic will be fined 100 B\$; those who violate or fail to observe the "digital quarantine order" is illegal behavior and can be fined up to 5000 B\$. If prosecuted by the court, they will face a fine of up to 10,000 B\$ or imprisonment up to 6 months, or both penalties.

III. Compnay Covid Prevention

1. Company publicity

1.1 Announcement of Company Covid Prevention Strategies: the latest Covid situation and the Company's regulations are updated every day in staff group chats.

2. Logistics supports

2.1 Office Area: routine disinfection in offices, vehicles each day going normal.

2.2 Personnel Status: Vehicle drivers, office cleaners, canteen workers in compliance with COVID prevention regulations, with health conditions being monitored 24/7.

2.3 Dorm Management: Dorms are in lockdown, with ppl going out during non-working hours being tracked. Online appointment 8 hours ahead is required for those leaving the dormitory in non-working hours.

3. Health monitoring and medical care services

3.1 HSE Dept checks temperature and mask-up compliance everyday.

3.2 After investigation, a total of 41 direct close contacts have been isolated and observed as required. So far, 31 expat workers tested negative, and will undergo a 1-week self-isolation and plan to come to work on 20 Aug. 10 of local workers tested negative so far, other ppl waiting the results.

3.3 The emergency clinic on the PMB is operating normally, the Company is continuously checking on its self-enclosed management.

3.4 COVID-19 prevention medicine: 99 boxes of Lianhua Qingwen capsules for cold, 99 boxes of Jinhua Qingqing particles for cold, 75 big bags of Ban Langen granules.

3.5 to ensure covid safe, MOH will send medical workers on the island on 19 Aug to do COVID tests for 45 related staff members. Staff info has been submitted to MOH.

4. Communications with the government

Had video conferences with ME/PA on 16 August, reported COVID prevention measures to PA. Will update COVID prevention daily reports to PA.

5. Materials Assurance

5.1 Materials inventory

Material consumption status: 50 disposable protective clothing, 25 medical gloves. 18 spraying disinfectant, 37 bottles of sanitizers, 6 bottles of disinfection liquids (3L).

Materials currently in stock: 2167 disposable medical surgery gowns; 2,335 KN95 Masks; 82,050 disposable masks, 9250 medical gloves; 5 thermometers; 368 protective goggles. 71 spraying bottles (2L); 96 bottles of disinfectant sprays; 775 bottles of sanitizers; 677 gallons of big bottles of disinfectant liquids (1 gallon/bbl); 84 bottles of disinfectant liquids (3L).

6. Contractor Management During the COVID-19 Pandemic

A total of 210 ppl in lockdown, with living areas disinfected and body temperature being checked twice a day. Everything normal.
