



III. Management Responsibilities

管理职责

1. Design Team: Responsible for design organisation and coordination at all stages of the project; managing design interfaces; organising design reviews and confirmation of design documents; supporting technical exchanges; overseeing design progress and design changes; cooperating with the HSE Team on risk assessments and with the Project Compliance Team on project approvals.

2. reviews during design stage; participating in program evaluations and providing improvement recommendations; overseeing environmental protection, security, fire safety, and occupational hygiene during construction; coordinating safety risk control and compliance management throughout the construction phase.
